What is Modern Slavery?



Definition and statistics/ impacts:

Modern slavery refers to situations of exploitation in which a person cannot refuse or leave because of threats, violence, coercion, deception, or abuse of power.

Modern slavery is an umbrella term and includes:

- Human trafficking
- Debt bondage
- Forced marriage
- Slavery and slavery-like practices
- Forced labour
- Worst forms of child labour
- Deceptive recruiting for labour or services

The most vulnerable globally – women, children and migrants - remain disproportionately affected. More than 12 million of all people in modern slavery are children, and women and girls account for over half of them 54%.

The significant characteristic of all forms of modern slavery is that it involves one person depriving another person of their freedom for profit. Its cost is individual freedom and economic stagnation. Its impact is global, and no country is immune.

Eire continuously fosters robust partnerships with a diverse array of Australian suppliers, given our procurement spans a wide spectrum of goods and services. From essential office stationery to high-quality construction materials, specialised plant and equipment, and skilled labour, our focus remains to support local industries while meeting our operational needs. A comprehensive analysis of Eire's expenditure for FY2024 has yielded valuable insights into our procurement patterns, highlighting the depth of our investment in the Australian economy.

While Eire is proud to partner with Australian-based suppliers, it's important to acknowledge that a number of these suppliers may source materials and products from international markets.

- All suppliers are located within Australia. Some are likely to source material and supply items from countries outside Australia.

- 36% of this annual expenditure is with suppliers that are registered on modernslaveryregister.com.au.

- A further 27% of this annual expenditure is with suppliers that Eire has engaged positively with the supplier on Modern Slavery through a detailed supplier questionnaire.

- As such 63% of Eire's annual expenditure is with suppliers that are registered or positively engaged with Eire around Modern Slavery.

Our Methodology

01.

Assessing and Addressing Risk

Eire is taking a proactive and comprehensive approach to assessing the risk of modern slavery within our supply chain. Eire have a guiding policy to combat Modern Slavery risks within our business. Our agreements with suppliers and contractors include specific clauses and assertions related to modern slavery, underscoring our commitment to ethical practices.

Our methodology begins with a thorough review of existing suppliers to verify their registration on the modern slavery register, which is then recorded in our supplier database. We also distribute a modern slavery questionnaire to all current suppliers, requiring new suppliers to complete this questionnaire before engagement.

02.

Assessment of Effectiveness

Upon receipt, each questionnaire is carefully reviewed, and suppliers are assigned a modern slavery risk rating, which is subsequently entered into our database. This risk rating plays a crucial role in our supplier selection process prior to contract awards, ensuring that modern slavery risk is a key consideration in our decision-making.

In the next phase, Eire will engage directly with our major suppliers to map their entire supply chains, allowing us to pinpoint potential modern slavery risks more effectively.

Consultation

Once risks are identified, we will collaborate with suppliers to address any concerns and implement strategies to mitigate identified risks, reinforcing our commitment to ethical sourcing and corporate responsibility.

At Eire, we are deeply committed to upholding the highest ethical and social standards in all our operations, including the critical issue of modern slavery.

We believe that every step we take matters, and that's why we're dedicating ourselves to thoroughly understanding and mapping our supply chain.
